RULES OF ORDER OF BUSINESS

The House of Delegates shall convene on Saturday, May 30, 2020. The meeting is scheduled to take place from 9:00 am to projected adjournment of noon.

DELEGATE ACCREDITATION: The Secretary/Treasurer shall furnish the Credentials Committee a list of the accredited Delegates and Alternates. The Chairman of the Credentials Committee shall certify and call the Delegates and Alternates to be seated. They must be ratified members in good standing of MOA.

DELEGATES' SEATING: A Delegate, having been seated, shall remain the accredited Delegate throughout the session, unless an Alternate is seated in his/her place. The Alternate shall be seated if the regular Delegate is not present and shall retain the chair for the entire session.

SPEAKER: The Speaker shall be the presiding officer and shall, with the approval of the House of Delegates, appoint the House Reference Committees.

VOTING PRIVILEGES: Each Delegate shall have one vote in the House. The Presiding officer shall vote only in the case of a tie vote.

SECRETARY: the Secretary/Treasurer of MOA shall be the Secretary of the House. Parliamentary rules of debate shall be observed and Robert's Rules of Order, Revised, shall be the guide to all deliberations, except when otherwise provided for in the MOA Bylaws.

SUSPENSION OF RULES: the Rules of Order of Business shall govern the procedure unless unanimously suspended by the vote of the House.

QUORUM: Forty of the voting members of the House shall constitute a quorum; and a quorum having been declared present at the first session, shall be declared present for the entire meeting.

GUESTS: The following persons shall be, during all but executive session, permitted to sit in the House without voice: a) members of the association, b) employees of the association, c) special guests.

Nominations and elections of officers and Delegates shall be held during the House session.

Angela Kalcec, President, Advocates of the Michigan Osteopathic Association (AMOA)

Mrs. Kalcec reported on the activities of the AMOA over the past year. Through the contributions received from members, AMOA has been able to support MSUCOM students and advocates, their programs and projects abroad. They continue to provide safe driving programs as well as focus on mental health and suicide awareness.

Lauren Stremers, President, Advocates for the American Osteopathic Association (AAOA)

Mrs. Stremers reported on the AAOA's partnerships and programs. She announced the organization's theme for the upcoming year as Advocacy Always; to highlight the importance of advocating for the osteopathic profession in new ways as the organization changes, while also staying true to its roots and history. The advocates will again host the fun run at OMED, in addition to their involvement in important initiatives such as the Physician Wellness Task Force and the Yellow Ribbon Suicide Prevention Program.

William Mayo DO, President & Ron Burns, DO, President-Elect, American Osteopathic Association (AOA)

Dr. Mayo reported on the growing osteopathic profession nationally, and the demographics of these physicians. He noted areas of strategic focus over the past year of osteopathic research and public policy. Internally, the AOA has been evaluating membership value and the strategic initiatives needed to keep physicians involved. Board Certification is one of the topics being addressed in this process, which will be changing moving forward.

Dr. Burns reported on items relating to AOA membership. He shared several benefits and programs which are offered to the membership and some that are in the creation process. Additionally, advocacy efforts are always in the AOA periphery, as they change and challenge the way physicians practice medicine.

Craig Magnatta, DO, President, Michigan Osteopathic College Foundation (MOCF)

Dr. Magnatta reported the Michigan Osteopathic College Foundation (MOCF) Board of Directors met on November 7, 2018 and approved the plans for the MOCF Ball on February 1, 2020. This will also be celebrating the Fiftieth Anniversary of Michigan State University College of Osteopathic Medicine. The MOCF fundraiser allows the Board to award scholarships, support for projects of the student organizations and growth of the MOCF endowment. The current book value of the MOCF endowment is \$8,500,000. The MOCF Student Impact Initiative has raised over \$300,000 this past year. The MOCF appreciates the support from the members of the Michigan Osteopathic Association in the past 50 years and hopefully for the next 50 years.

Andrea Amalfitano, DO, Interim Dean, Michigan State University College of Osteopathic Medicine (MSUCOM)

Dr. Amalfitano shared that the college will be celebrating its 50 year milestone this year, with commemorative activities, reflection and planning for the next 50 years. Part of this planning for the future of the profession will include engaging a younger population. Through the Future Docs program, the college is reaching out to middle and high schools, areas of underrepresented populations in the profession to educate them on this potential career path.

In addition, the college continues to see application numbers far exceed the 300 slots available at the college. In fact, there was a near 10% growth in applicants from last year. Dr. Amalfitano credits this growth to the culture of the college, opportunities available to students and work to keep the curriculum ever-relevant.

Dr. William Anderson was also invited to address delegates on the history of the college, his experiences and the osteopathic profession.

Drs. Bell & Glines reported on the function and process of the Board. With the recent changes in prescribing rules and regulations, the Board has seen an increase in investigations.

Mr. Lazar reported that the osteopathic physician organization has been across the state and involved in many sectors of healthcare advocating for members of MOA. Among other goals, the group seeks to increase frequency and ease of reimbursement with payors.

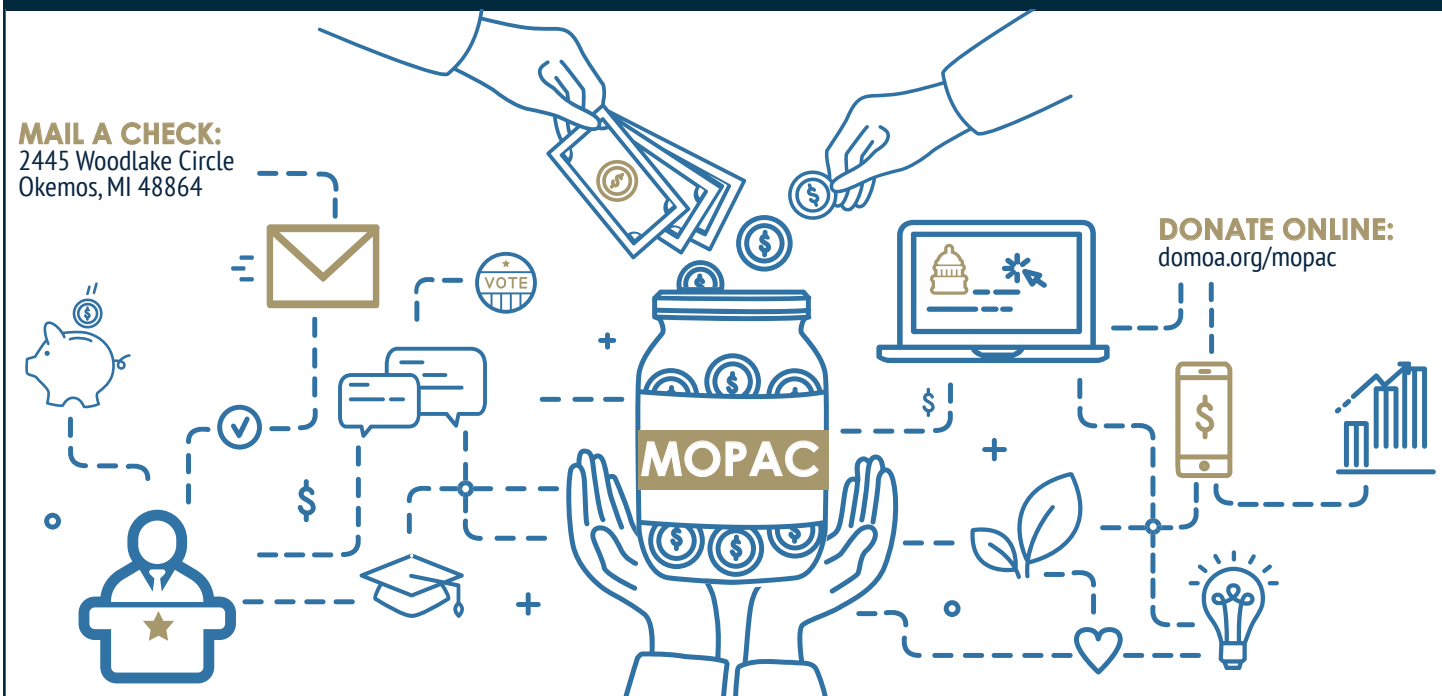

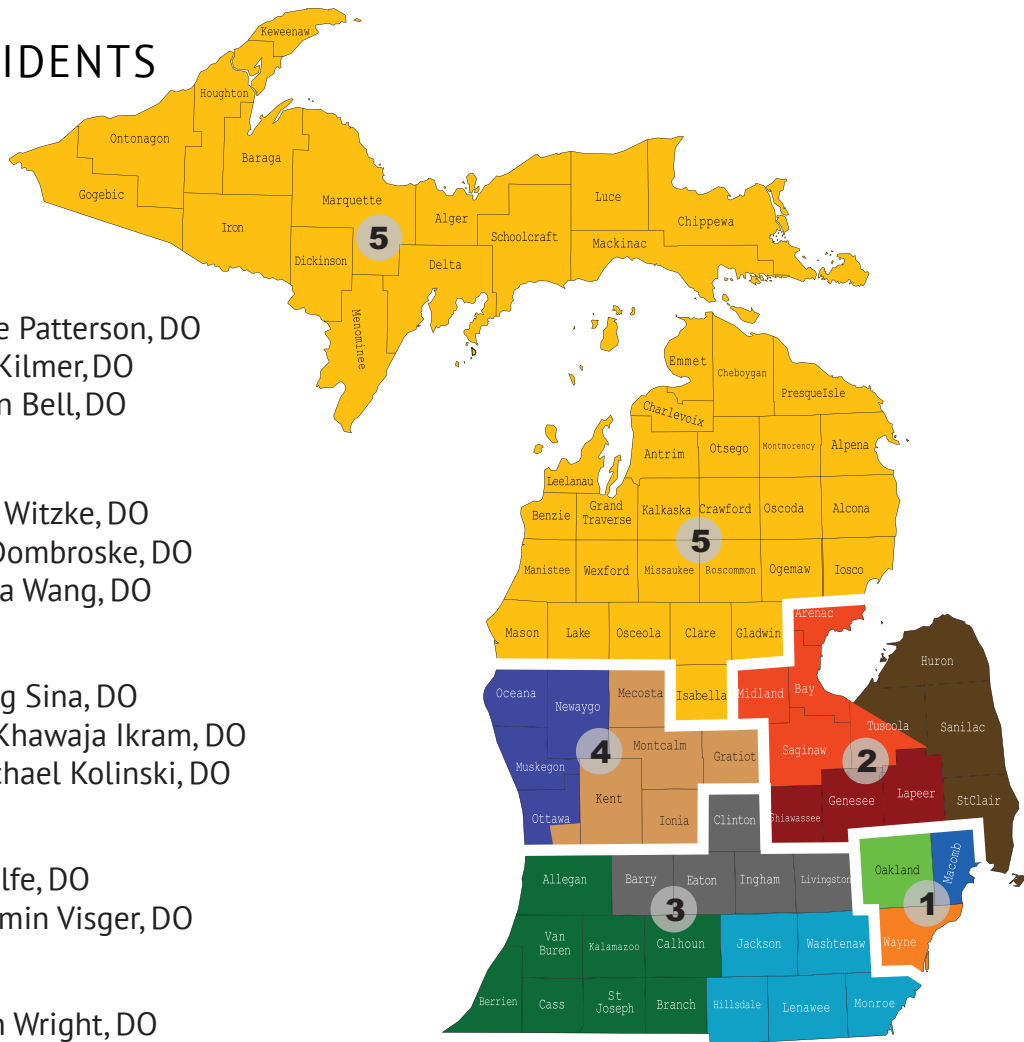

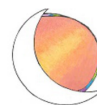
